1. The above results for the Quarter and half year ended September 30, 2018 have been reviewed by the Audit Committee at their meeting held on 14th November, 2018 and thereafter approved by the Board of Directors at its meeting held on November 14, 2018.

2. The above results are subject to Limited Review Report by the Statutory Auditors of the company.

3. The company is operating in two segments viz. Construction and Hotel

4. The company had reached a settlement with Aichemist Asset Reconstruction Company Ltd. In respect of loan taken over by them from State bank of India. Subsequently, after full and final payment of the settled amount in this respect, the company has received a-cues from them as it relates to the amount of debt of SBI. Subsequently, the company has written back the amount to the tune of Rs. 2,556.43 lakhs as part of the settlement relating to the SBI amount and has reflected the same in Other Income in first quarter.

5. The debts taken over by Aichemist Asset Reconstruction Company from Indian Overseas Bank was restructured and quarterly payments are being made as per schedule and sanction terms of the restructuring, to be paid quarterly till 31st March 2024.

6. Other Expenses reflects reversal of VAT to the tune of Rs. 18,19 Lakhs provided in excess in the previous year.

7. Provision for income tax is not made due to carry forward of unabsorbed losses of earlier years.

8. Provision for MAT, if any, shall be provided at the end of the year on annualised basis.

9. Company has not received any declaration/notice/letters from the creditors certifying or indicating them as Micro Enterprises and Small Enterprises.

10. Previous year's figures have been re-grouped / re-arranged wherever necessary.
