According to Tanishq, the present campaign demonstrates what consumers should look for. According to a note by the company, the campaign is meant to familiarise customers with the brand's eight point verification and certification process.

It is not just big, national brands such as Tanishq that are using transparency and authenticity as a plank to talk to their customers. The 118year old regional brand Vummidi Bangaru Jewellers (VBJ) recently set up a synsing thetic diamond screening

Sachin Jain, president, Forevermark said that they will invest in awareness campaigns across the Indian market. Speaking to the media earlier Jain had said, "There was an initial jolt (post-Nirav Modi scam) where customers were worried about quality of the diamonds. But everyone has moved on and people are back to investing in dia-monds from brands they trust." Going by the spate of recent campaigns, it does seem that there is still more time before his hopes translate into reality.
